I have built and grown large globally dispersed teams of up to 150 people (FTEs and contractors), heading multiple verticals within Google's Legal Content Policy & Standards team in Trust & Safety based on an organization structure I proposed in 2018. My teams successfully scale operations through automation to meet growing demand despite increasingly limited resources. I manage a complex relationship between Google's business units and major customers to enhance compliance, combat fraud, and protect users from illegal and harmful content. My work is frequently subject to external press and regulator inquiries, and I regularly work with Senior Google Leadership to represent our policies and processes externally.

Head of Product - Legal Content Policy & Standards

- Head a team of product specialists representing each Google Product Area, who are tasked with developing technical solutions for content moderation across a wide variety of platforms, including generative Al. My teams interface with product managers, engineers, and executives on the safe design of new product features to minimize legal risk and user harm.
- Established annual business review process to share commercial success of content moderation operations with senior product leadership.
- Imbued team with a new culture of data-driven strategy to enhance collaboration between T&S teams by instituting data sharing practices for proactive identification of business risks.
- Negotiated with legal and product engineers to secure optimal outcomes for trust & safety operations in line with regulatory requirements, resulting in minimal OpEx increases to comply with major regulations such as the EU Digital Services Act.
- Managed implementation of new AI products into trust & safety compliance ecosystem, including large language models (LLMS), generative imagery, music, and productivity software

Head of Global Copyright Policy & Operations

Sept. 2018 - Present

- Head of world's largest copyright notice and takedown system, overseeing a a massive operation to review and respond to growing demand, which increased from 600 million to 1.3 billion instances of alleged copyright infringement since 2020.
- Established a transformational vision for team that instituted strategic use of 3rd party vendors and new engineering solutions to reduce manual enforcement, while simultaneously replacing an outdated team model with new globally applicable policies that aligned business needs with T&S enforcement.
- Increased fraud detection over 300% in first two years with iterative gains of 20-30% YoY and worked with Comms teams to address <u>Wall Street Journal investigation into fraudulent legal complaints</u>. In 2023, our fraud prevention efforts uncovered a scheme resulting in \$3M in losses to Google and \$10M in client losses, then successfully convinced <u>Google Legal to sue the fraudsters</u>.
- Oversaw initiative to reduce livestream copyright infringement across various Google products and influenced executive adoption of program leading to >\$10M in annual bandwidth savings for Google Cloud and new mitigations to prevent fraudulent credit card sign-ups.
- Moved 40 contractors from the US to India in 2023 resulting in \$6M in annual OpEx savings.

Interim Head of Americas and Russia Region

- Interim Head of Google Legal Removals Americas and Russia team with oversight for legal content policy and operations in North America,
 South America, and Russia
- Assumed role in Sept. 2021 and immediately lead the riskiest executive escalation ever encountered by our team regarding a <u>Russian order to</u> censor political opposition content from Alexei Navalny. Advocated for human rights based approach, and collaborated with regional based stakeholders to maintain access to political content and avoid negative user impacts.
- Hired and onboarded an entirely new team of Latin American, US, Canadian, and Russian regional policy leads over the course of 7 months.
- Led my organization's response to the outbreak of conflict in Ukraine. Setup customized T&S workflows to address conflict driven user
 complaints; established 24/7 staff coverage to respond to urgent demands; and worked with senior Google leadership to respond to various
 sanctions against Russian state-sponsored content.

Established new lead role for data analysis and built internal team to handle data related projects. Led to complete overhaul of our productivity tracking and SLA evaluation for content moderation queues.
- Stewarded technical compliance plans for various content moderation regulations, including EU Platform-to-Business, EU Copyright Directive, Protection from Online Falsehoods and Manipulation Act, and French Hate Speech.
- Created and managed project team to handle end-to-end implementation of new CRM system, and negotiated 6-month extension of existing system to allow time for new implementation. Team migrated all data and workflows ahead of schedule against tight 8 month deadline by fostering close collaboration between technical and operational teams.
